

# **COVID-19 DAILY STATUS REPORT**

### **CURRENT STATUS:**

- As of 3:30 p.m. Tuesday, March 23, 2021, there are 30,298 confirmed cases (+41 from Monday) of COVID-19 (novel coronavirus) in Merced County. Approximately 698 of those cases are active, and 430 have died.
- Current Risk Tier: Purple (Widespread). Many non-essential indoor business operations are closed.
  - Tiers are determined by the California Department of Public Health based on test positivity and adjusted case rate. Counties can move into more or less restrictive tiers based on these factors. Weekly tiers are updated on Tuesdays. More information: www.covid19.ca.gov/safer-economy/

- Please note: The State is in the process of launching a new vaccine-scheduling platform known as "My Turn." That platform is not yet available in Merced County and more information will be provided once it's made available in coming weeks. Those who have already received their first dose of the vaccine with the Merced County Department of Public Health will be notified by a third-party agency called HR Support to schedule their second dose in order to complete the vaccination series and become fully vaccinated.
- In an effort to slow the spread of COVID-19 by preventing large group gatherings, the
  County's regional parks (Lake Yosemite, Hagaman Park and Henderson Park) will be closed
  on Saturdays and Sundays until further notice. The parks will remain open on weekdays, but
  physical distancing must be adhered to and large group gatherings will continue to be
  prohibited.
- The Merced County Office of Emergency Services and Merced County Department of Public Health proclaimed a local and public health emergency March 13 in order to help address the outbreak. The Board of Supervisors ratified those actions during a March 16 special meeting.
- The Merced County Public Health Department Operations Center was activated Jan. 27, 2020
  (422 days) in order to prepare for COVID-19 in and around our community. The Merced
  County Emergency Operations Center and Human Services Agency Department Operations
  Center are also currently active.

# COVID-19 Vaccination Distribution: Phase 1 As of March 15, 2021

The supply of COVID-19 vaccine continues to be limited, which means that the vaccine will be offered to different groups of people in different phases, starting with our healthcare workers. To ensure that vulnerable groups continue to be prioritized, the providers in Merced County are authorized to manage vaccine eligibility at their own discretion when serving patients.

Green circle indicates that the group has been offered the vaccine. Yellow circle indicates that the group is waiting to be offered the vaccine.

Red circle indicates that the vaccine is not yet available at this time.

### Phase 1A

- Acute care, psychiatric and correctional facility hospitals
- Skilled nursing facilities, assisted living facilities, and similar settings for older or medically vulnerable individuals
- Residents in long-term care
- Paramedics, EMTs, and others providing emergency medical services
- Dialysis centers

### Phase 1B

### Tier1:

- Persons 65 years and older
- Frontline Essential Workers Sectors: education, childcare, emergency services (such as law enforcement), and food and agriculture (see attached, Appendix A for details)

## Phase 1C

- Persons 50-64 years old
- Persons 16-64 years old with high risk health conditions

- Intermediate care facilities for persons who need non-continuous nursing supervision and supportive care
- Home health care and in-home
- Public Health field staff
- Primary care clinics, including Primary care clinics, including federally qualified health centers, rural health centers, correctional facility clinics, and urgent care clinics
- Community health workers, including promotoras

### Tier 2: Frontline Essential Workers

Sectors: public transit workers and airport and commercial airline workers; transportation and logistics; industrial, commercial, residential, and sheltering facilities and services; critical manufacturing

Congregate settings with outbreak risk

### Homeless

Sectors: water and Wastewater, government operations, community-based essential functions, defense, energy, chemical/hazardous materials, finance services, and IT/communication:

## Appendix A: Phase 1B, Tier 1 - Frontline Essential Workers

The list below will provide further information about Frontline Essential Worker eligibility under Phase 1B of the vaccine distribution plan. To ensure that vulnerable groups continue to be prioritized, the providers in Merced County are authorized to manage vaccine eligibility at their own discretion when serving

Vaccine supplies continue to be limited in Merced County. The list below provides further guidelines for Frontline Essential Workers that are eligible for the vaccine, at this time:

### Eligible for Vaccination

- · Education and childcare sectors
- Formal and informal childcare workers, including day care providers, foster care, children's residential community care facilities, librarians, bus drivers, and all staff involved in student and/or child care
- Emergency Services including law enforcement, utility workers, disaster service workers, and social
- · Farmers, farm and ranch workers, and agribusiness support services.
- · Veterinary health, animal diagnostic and food testing laboratories.
- · Workers in food manufacture and maintenance of equipment associated with infrastructure necessary to food/ agricultural production and
- · Food manufacturer and supplier workers (includes poultry and livestock).
- · Workers at animal care facilities that provide food. shelter, veterinary/routine care.

### Eligible for Vaccination

- Retail store workers (groceries/convenience stores,
- · Restaurant workers (includes carry-out and quick serve food operations).
- Workers in sanitation of operations from wholesale
- . Workers in growth/distribution of plants and associated products for home gardens
- Workers in sawmills, fiber and forest manufactures/distributors.
- · Workers in cafeterias used to feed workers particularly worker populations sheltered against COVID-19.
- . Government, private, and non-governmental organizations' workers essential for food assistance programs (including school lunch programs) and government payments.
- · Workers at production, storage, transport, and distribution of chemicals and medicines
- · Transporters supporting animal agricultural

- Within the public health system, every person who has met CDC criteria for severe disease within Merced County has been tested.
- Public Health is actively identifying other methods to enhance testing capability for providers throughout the community and increase testing county-wide. We will continue to be notified should positive tests come through either system (public health or commercial).

### **COVID-19 SYMPTOMS AND PRECAUTIONS:**

- Coronavirus symptoms include: mild to severe respiratory illness, fever, cough, difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, and loss of taste or smell. If symptoms develop, individuals should stay at home to limit exposure to others.
- Anyone who has had contact with a person with possible COVID-19 infection and has the above symptoms should call his/her local health department/health care provider immediately.
- Do not go to your provider's office without calling ahead. Do not call 911 for suspected COVID-19 unless you are having a medical emergency.
- During the flu season, there are steps you can take to protect your health and the health of those around you:
  - Wash your hands regularly with soap and water for 20 seconds.
  - Avoid touching your eyes, nose, or mouth with unwashed hands.
  - Avoid close contact with people who are sick.
  - Stay away from work, school or other people if you become sick with respiratory symptoms such as fever and cough.
  - Cover sneezes or coughs with a tissue, then throw the tissue in the trash.
  - Wear a face covering when in public.
