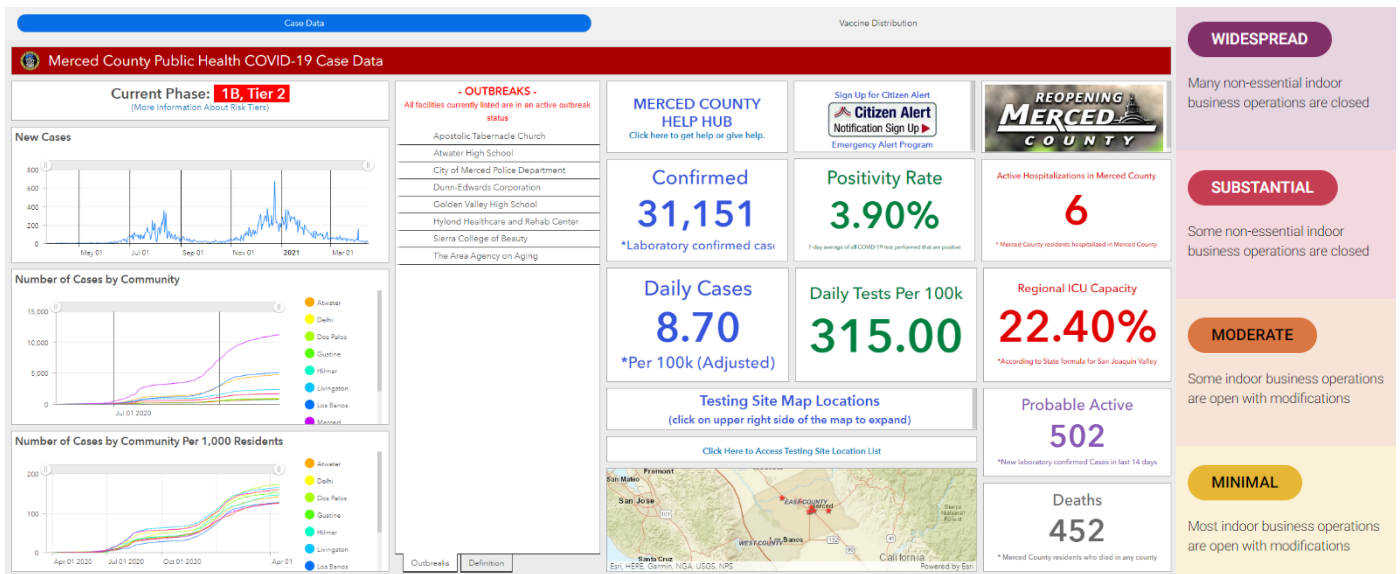

**COVID-19 DAILY STATUS REPORT**

**CURRENT STATUS:**

- As of 3:30 p.m. Thursday April 15, 2021, there are 31,151 confirmed cases (+23 from Wednesday) of COVID-19 (novel coronavirus) in Merced County. Approximately 502 of those cases are active, and 452 have died.
- Current Risk Tier: Red (Substantial).** Some non-essential indoor business operations are closed.
  - Tiers are determined by the California Department of Public Health based on test positivity and adjusted case rate. Counties can move into more or less restrictive tiers based on these factors. - Based on information provided by individuals who test positive, Public Health staff will continue to assess risks of exposure and contact any affected individuals.
- Due to privacy laws, the Public Health Department cannot release identifying information related to positive cases.
- In California, there are 3,608,898 confirmed cases and 59,508 deaths.

- California Aims to Fully Reopen June 15:
  - The move forward comes as the state has reached 20 million vaccinations, including 4 million in its hardest-hit communities. Masking and vaccinations will continue. Hospitalization rates must stay low and vaccination availability high for the state to fully reopen.

- In an effort to slow the spread of COVID-19 by preventing large group gatherings, the County's regional parks (Lake Yosemite, Hagaman Park and Henderson Park) will be closed on Saturdays and Sundays until further notice. The parks will remain open on weekdays, but physical distancing must be adhered to and large group gatherings will continue to be prohibited.
- The Merced County Office of Emergency Services and Merced County Department of Public Health proclaimed a local and public health emergency March 13 in order to help address the outbreak. The Board of Supervisors ratified those actions during a March 16 special meeting.
- The Merced County Public Health Department Operations Center was activated Jan. 27, 2020 (445 days) in order to prepare for COVID-19 in and around our community. The Merced County Emergency Operations Center and Human Services Agency Department Operations Center are also currently active.

The supply of COVID-19 vaccine continues to be limited, which means that the vaccine will be offered to different groups of people in different phases, starting with our healthcare workers. To ensure that vulnerable groups continue to be prioritized, the providers in Merced County are authorized to manage vaccine eligibility at their own discretion when serving patients.

### Appendix A: Phase 1B, Tier 1 - Frontline Essential Workers

The list below will provide further information about Frontline Essential Worker eligibility under Phase 1B of the vaccine distribution plan. To ensure that vulnerable groups continue to be prioritized, the providers in Merced County are authorized to manage vaccine eligibility at their own discretion when serving patients.

Vaccine supplies continue to be limited in Merced County. The list below provides further guidelines for Frontline Essential Workers that are eligible for the vaccine, at this time:

- Within the public health system, every person who has met CDC criteria for severe disease within Merced County has been tested.
- Public Health is actively identifying other methods to enhance testing capability for providers throughout the community and increase testing county-wide. We will continue to be notified should positive tests come through either system (public health or commercial).

#### **COVID-19 SYMPTOMS AND PRECAUTIONS:**

- Coronavirus symptoms include: mild to severe respiratory illness, fever, cough, difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, and loss of taste or smell. If symptoms develop, individuals should stay at home to limit exposure to others.
- Anyone who has had contact with a person with possible COVID-19 infection and has the above symptoms should call his/her local health department/health care provider immediately.
- Do not go to your provider's office without calling ahead. Do not call 911 for suspected COVID-19 unless you are having a medical emergency.
- During the flu season, there are steps you can take to protect your health and the health of those around you:
  - Wash your hands regularly with soap and water for 20 seconds.
  - Avoid touching your eyes, nose, or mouth with unwashed hands.
  - Avoid close contact with people who are sick.
  - Stay away from work, school or other people if you become sick with respiratory symptoms such as fever and cough.
  - Cover sneezes or coughs with a tissue, then throw the tissue in the trash.
  - Wear a face covering when in public.
