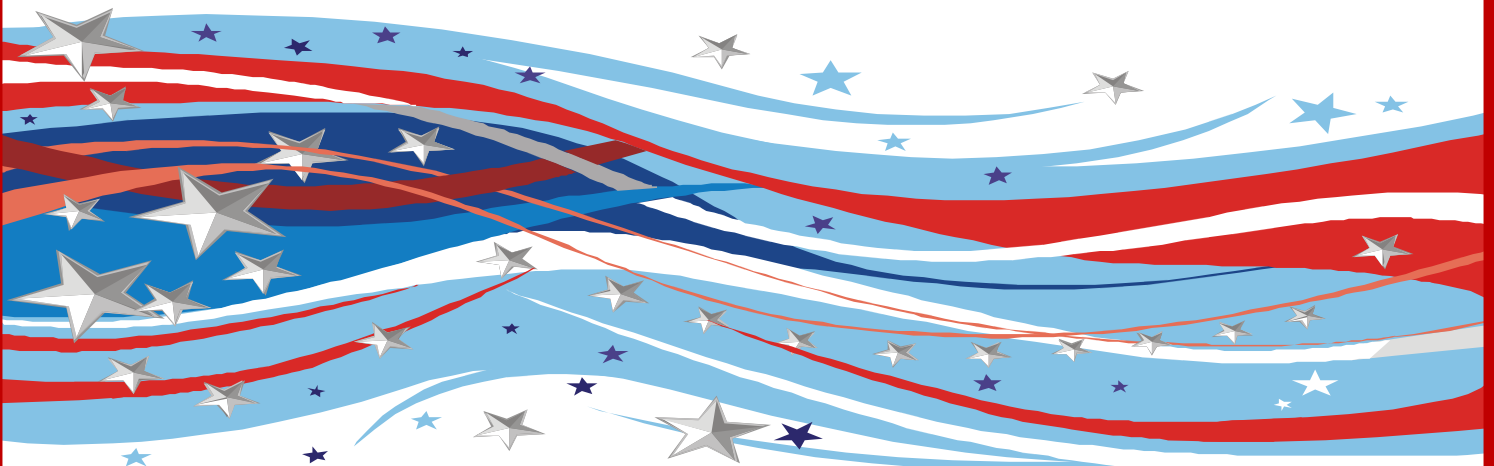



Notice of the drawing of precincts was given by press release and posted in the office lobby and on our website one week prior to the date of the random selection.

The random selection of precincts was conducted in the Elections Warehouse lobby on Thursday, August 24, 2016 at 8:00 am. Slips of paper containing precinct numbers were drawn from a container to select the precincts to be fully tallied (2).
